### Finalisation information in relation to the Rights Offer (Pursuant to the MSE Listings Requirements)

The Company's Shareholders are referred to the announcement released in the press on 11 October 2024 and the second announcement released in the press on 21 October 2024 which dealt with the fully underwritten renounceable rights offer of 5,038,504,230 ordinary shares ("**Rights Shares**") at a discounted issue price of K12.38 per share in the ratio of 6 Rights Shares for 1 existing ordinary share held (the "**Rights Offer**").

All conditions precedent relating to underwriting agreements and the Rights Offer have now been fulfilled, and a prospectus (the "**Prospectus**") that provides comprehensive details of the Rights Offer will be dispatched to shareholders on or about 25 November 2024. Shareholders will also receive a printed Letter of Allocation (which includes a Form of Subscription Instructions) in respect of the renounceable (nil paid). For Non-Shareholders wishing to apply for BHL shares in the Rights Offer a BHL Share Application Form (for use by Non-Shareholders) has been provided both in manual and electronic forms. An application was made to the Committee of the Malawi Stock Exchange ("**MSE**") for a listing of the renounceable Letters of Allocation and shares proceeding from their acceptance. The MSE granted its approval on 14 November 2024. The renounceable Letters of Allocation will trade under the MSE code of "**BHL**" under the name Blantyre Hotels Plc.
