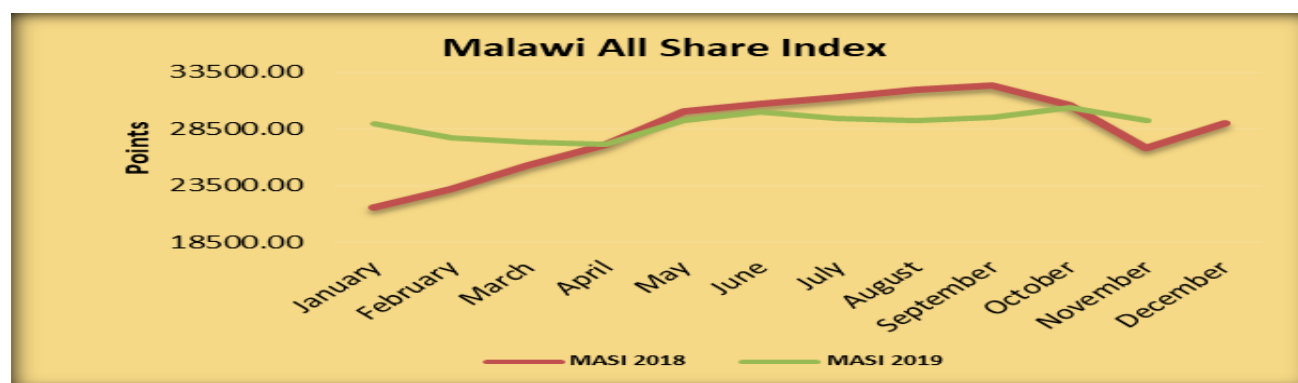
1. TRADING SUMMARY

The market registered a negative monthly return on index of **3.72%** (4.20% in US\$ terms), **0.80%** YTD [**9.00%** Y-O-Y]. It however, registered an increase in both total volume of shares and total value traded.

There were no trades on the listed debt securities.

2. MARKET PERFORMANCE

A. Trade Performance Analysis

The market transacted a total of 342,696,807 shares at a total consideration of MK7,012,268,671.68 (US\$10,113,211.95) in 307 trades. In the previous month, October 2019, the market transacted a total of 185,453,439 shares at a total consideration of MK2,495,407,311.96 (US\$3,404,409.97) in 243 trades. This reflects a **84.79%** increase in terms of share volume traded and a **181.01%** (**197.06%** in US Dollar terms) increase in share value traded. Of the total volume of shares traded 155,265,65279 NBS and 6,022,371 NICO shares traded as negotiated deals.

Daily average share trades exhibited similar trends where the market registered an average daily volume of 16,318,896 shares compared to 8,831,116 shares traded in November 2019.

The average daily turnover for November 2019 was MK333,917,555.79 (US\$481,581.52) compared to MK118,828,919.62 (US\$162,114.76) in October 2019, reflecting an increase of **181.01%** (**197.06%** in US Dollar terms).

B. Market Capitalization and Index

The market registered a negative return on index as reflected in the downward movement of the Malawi All Share Index (MASI) from 30344.49 points registered in October 2019 to 29215.33 points registered in November 2019, giving a month-on-month return on index of **-3.72%** (**-4.20%** in US\$ terms). The price gain registered by NBM(0.004%) was not enough to offset share price losses registered by ILLOVO (27.14%) and FMBCH(6.25%) resulting into a downward movement of the Malawi All Share Index. The Domestic and Foreign Share Indices closed at 22664.27 and 4024.86 points respectively.

Market capitalization decreased in both Malawi Kwacha and United States Dollar terms from MK1,433,241.37 million (US\$1,955.33 million) in October 2019 to MK1,380,637.57million (US\$1,874.20 million) in November 2019.

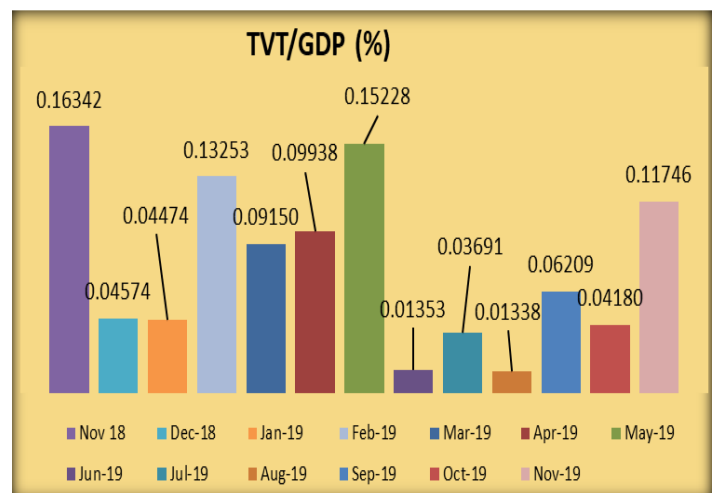
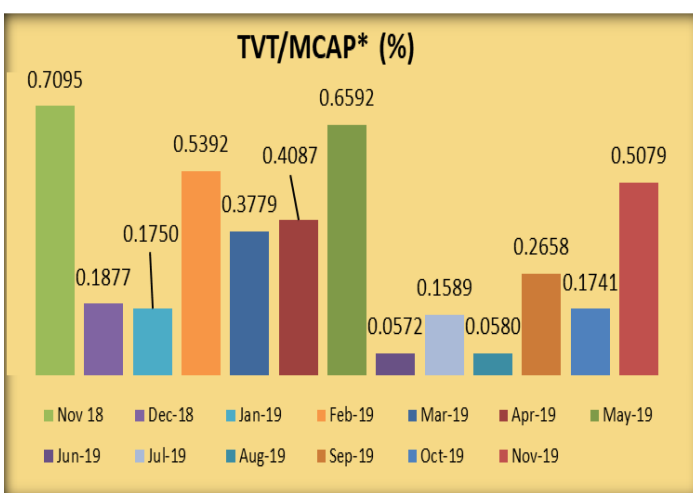
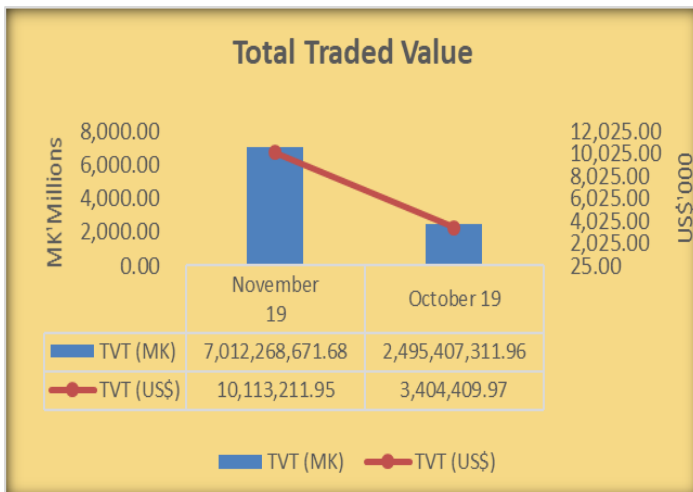
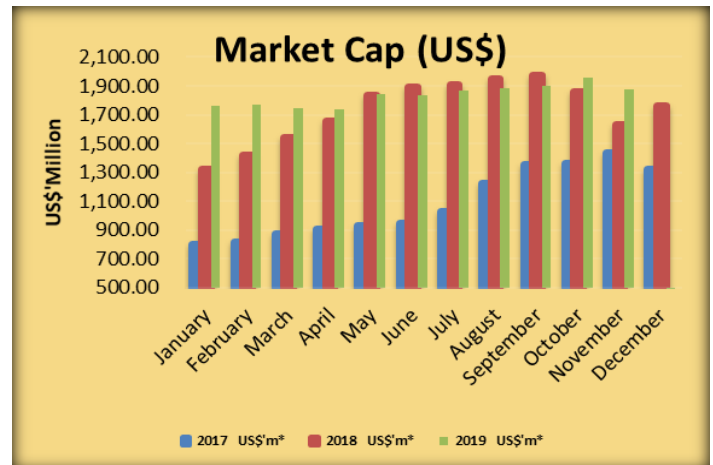
C. Market Liquidity

The turnover velocity measured by the ratio of Total Value of Trades to Market Capitalisation (**TVT/MCAP***), an indicator of the liquidity of assets traded on the market, in November 2019 was recorded at 0.51%, higher than 0.17% registered in October 2019. The ratio of Total Value of Trades to Gross Domestic Product (**TVT/GDP**) recorded a liquidity level of 0.12% in November 2019 while during the previous month, October 2019, liquidity was at 0.04%. Market capitalization as a percentage of GDP was at 23.13% in November 2019 and 24.00% in October 2019.

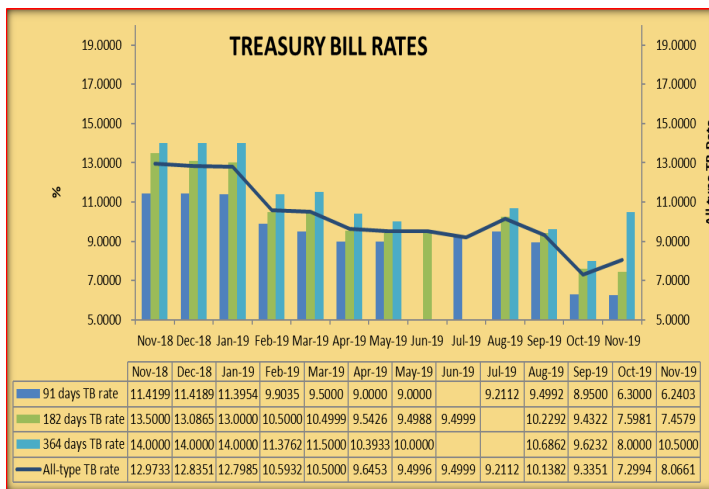

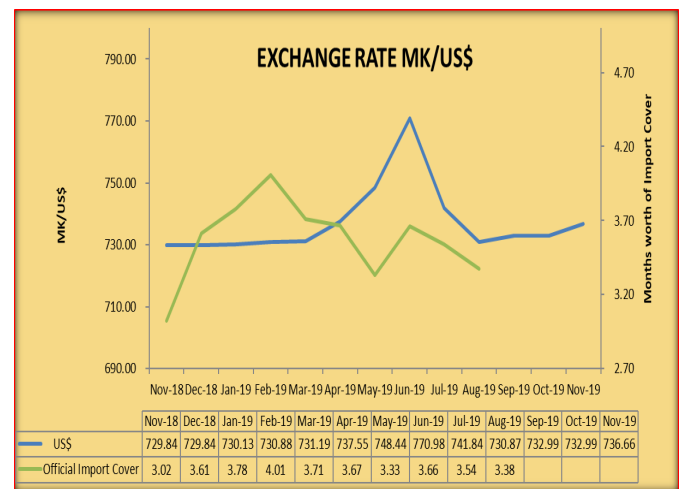
Interest Rates

During the period under review, the yields on the 91 days T-bill and the 182 days T-bill fell by 0.0597% from 6.3000% to 6.2403% and by 0.1402% from 7.5981% to 7.4579% respectively, whilst the 364 days T-bill inched upwards by 2.5000% from 8.0000% to 10.5000%.



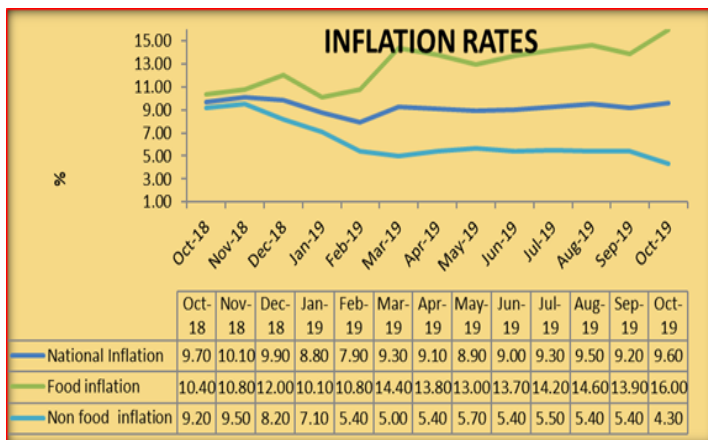
Exchange Rates

The Kwacha marginally depreciated by 0.50% against the United States Dollar in the period under review. Gross official reserves were at 3.38 months worth of import cover on 31 August 2019.



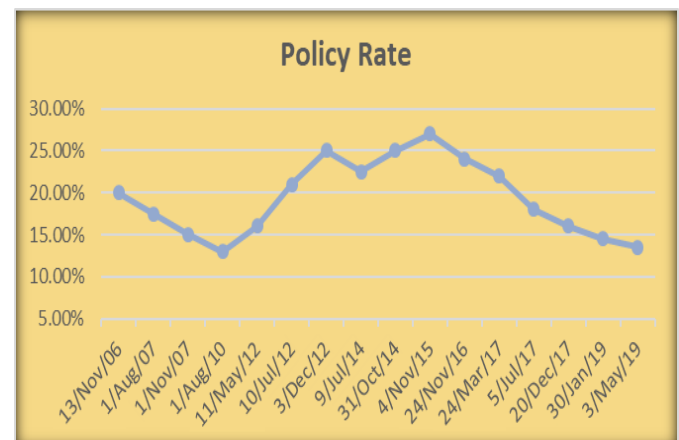
Inflation Rates

Headline inflation inched upwards by 0.4 percentage points from 9.2% in September, 2019 to 9.6% in October, 2019.



Monetary Policy Rate

The Monetary Policy Committee at its meeting held on 29 and 30 October 2019 maintained the policy rate at 13.5%.
