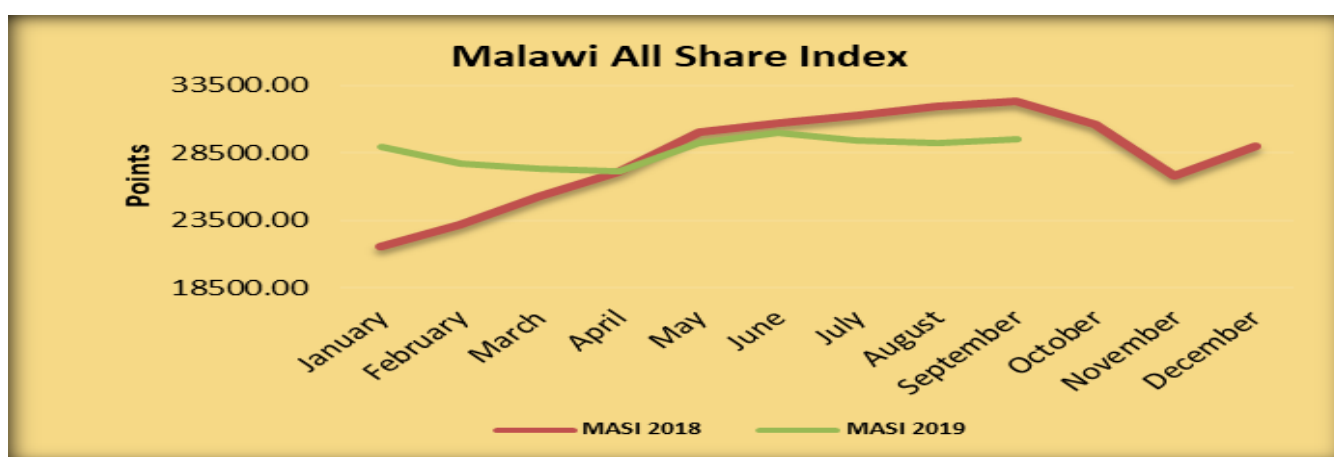
1. TRADING SUMMARY

In Q3 of 2019, the market registered a negative return on index of **-1.37%**(3.74% in US\$ terms), **1.94%** YTD, compared to **5.32%**(4.95% in US\$ terms) in Q3 2018. It also registered a decrease in terms of total value of shares traded despite registering an increase in total volume of shares traded.

A Treasury Note with a coupon of 9% was listed in September 2019.

2. MARKET PERFORMANCE

A. Trade Performance Analysis

The market transacted a total of 209,366,267 shares at a total consideration of MK6,709,006,554.78 (US\$9,152,898.07) in 721 trades. In the corresponding period 2018, the market transacted a total of 84,606,501 shares at a total consideration of MK7,358,084,929.80 (US\$10,139,590.24) in 508 trades. This reflects a **147.46%** increase in terms of share volume traded and a **-8.82%** (**-9.73%** in US Dollar terms) decrease in share value traded. Of the total volume of shares traded, 90,000,000 NBS, 100,000 OMU and 1,918,000 PCL shares traded as negotiated deals.

Daily average share trades exhibited similar trends where the market registered an average daily volume of 3,376,875 shares compared to 1,364,621 shares traded in the corresponding third quarter of 2018.

The average daily turnover for the third quarter 2019 was MK108,209,783.14 (US\$147,627.39) compared with MK118,678,789.19 (US\$163,541.78) for the corresponding third quarter 2018, reflecting a decrease of **8.82%** (**9.73%** in US Dollar terms).

B. Market Capitalization and Index

The market registered a negative return on index as reflected in the downward movement of the Malawi All Share Index (MASI) from 29956.00 points registered on 1 July 2019 to 29546.27 points registered on 30th September 2019, giving a return on index of **-1.37%**, (**3.74%** in US\$ terms) compared to **5.32%**, (**4.95%** in US\$ terms) registered in Q3 of 2018. The price gains registered on NBS(33.44%), STANDARD (6.35%) and NBM(5.67%) were not enough to offset share price losses in SUNBIRD (-14.49%), TNM(-10.31%), FMBCH(-5.88%) and NITL(-0.01%) resulting into a downward movement of the Malawi All Share Index. The Domestic Share and the Foreign Share Indices fell by **0.62%** and by **1.21%** respectively.

Market capitalization decreased in Kwacha terms from MK1,412,128.98 million on 1st July 2019 to MK1394,440.03 million on 30th September 2019. It however, increased in United States Dollar terms from US\$1,831.60 million to US\$1,902.39 million as a result of an appreciation of the Malawi Kwacha.

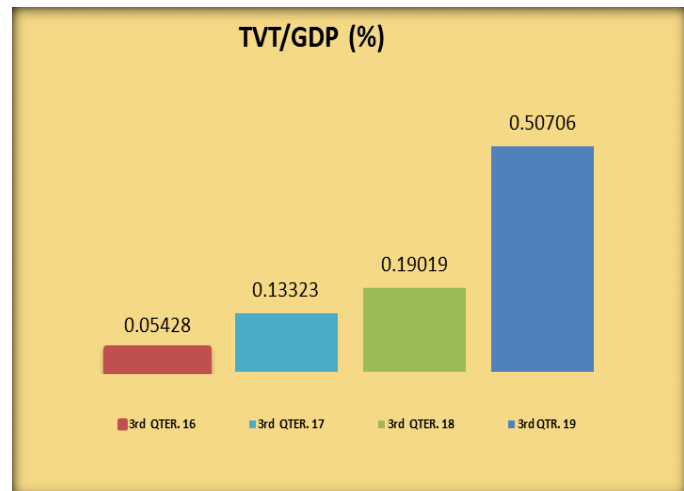
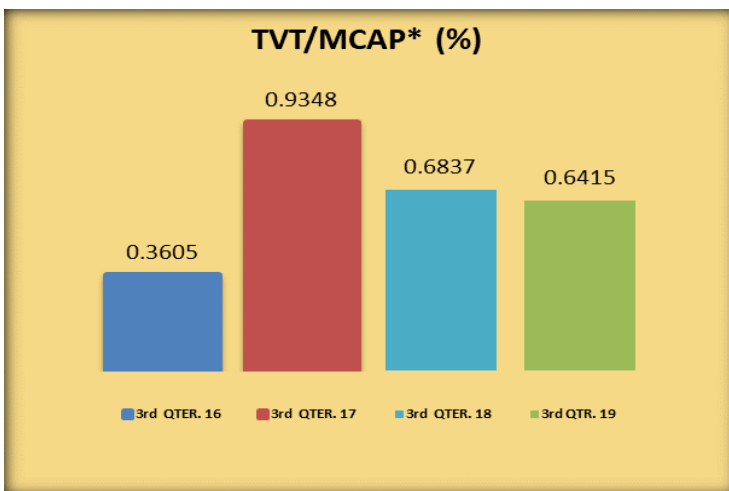
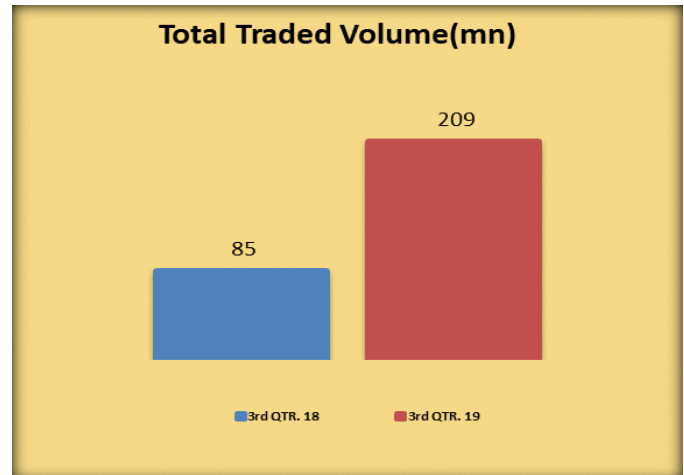
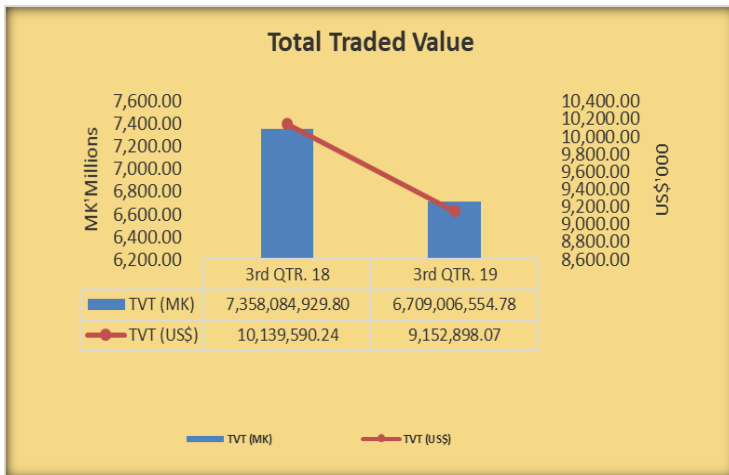
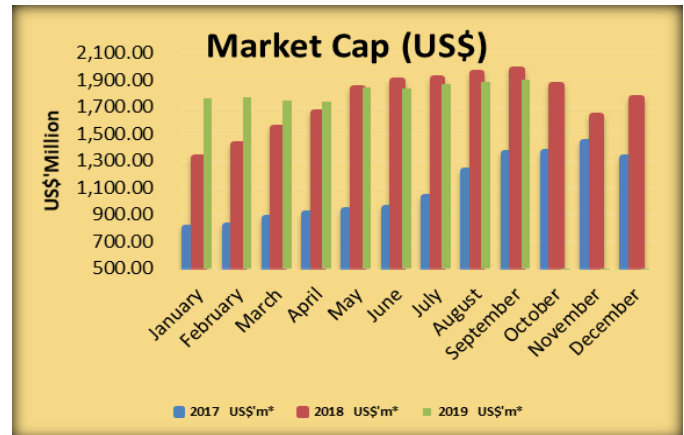
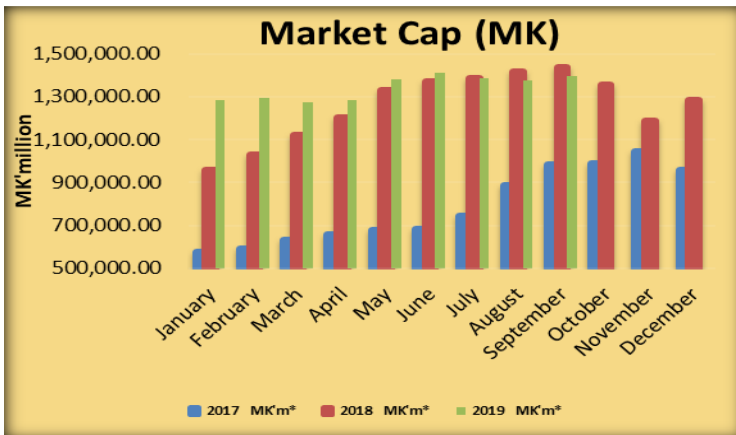
C. Market Liquidity

The turnover velocity measured by the ratio of Total Value of Trades to Market Capitalisation (**TVT/MCAP***), an indicator of the liquidity of assets traded on the market, in the quarter under review was recorded at 0.64%, lower than 0.68% registered in third quarter 2018. The ratio of Total Value of Trades to Gross Domestic Product (**TVT/GDP**) recorded a liquidity level of 0.15% in the review period while during the corresponding period of 2018 liquidity was at 0.19%.

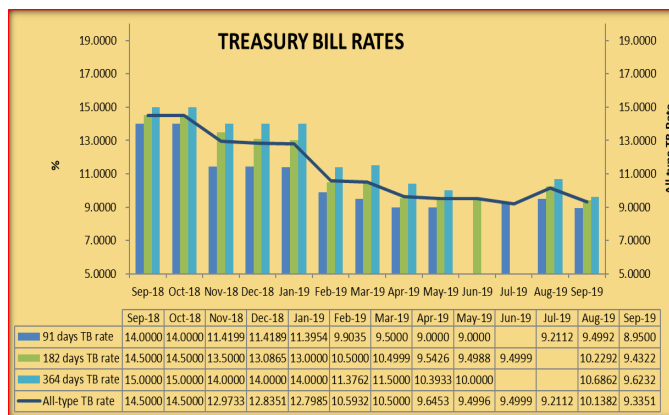

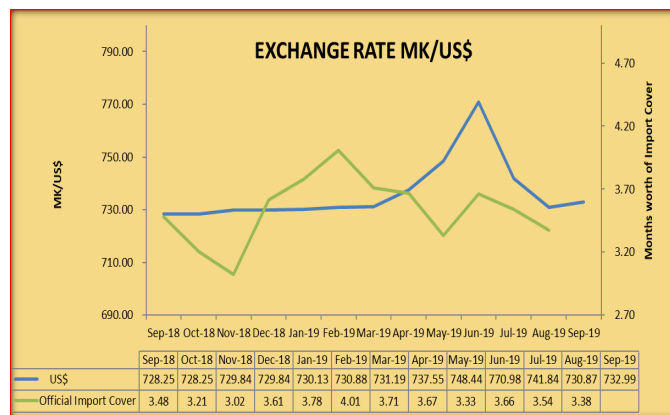
Interest Rates

During the quarter under review, the yields on the 91 days Tbill fell from 9.4322% to 8.9500% whilst the 182 and 364 days Tbill were at 9.4322% and 9.6232% respectively.



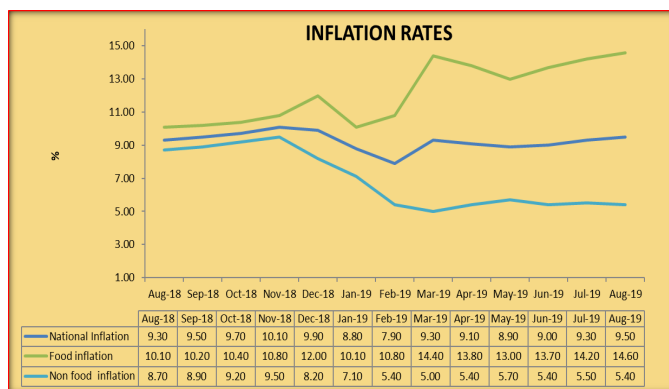
Exchange Rates

The Malawi Kwacha appreciated against the United States Dollar by 5.18% in the period under review. Gross official reserves decreased from 3.66 months of import cover on 30 June 2019 to 3.38 months of import cover on 31 August 2019.



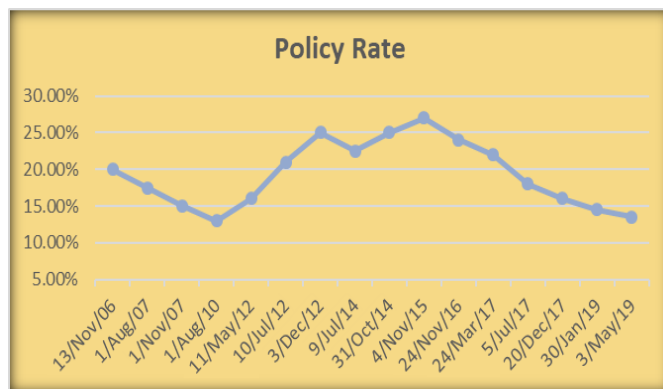
Inflation Rates

Headline inflation inched upwards by 0.2 percentage points from 9.3% in July, 2019 to 9.5% in August, 2019.



Monetary Policy Rate

The Monetary Policy Committee at its meeting held on 2 and 3 May 2019 reduced the policy rate from 14.5% to 13.5%.
